Mechanisms of Microevolution: How Populations Evolve

Natural Selection and Adaptation

Genetic Drift: The Role of Chance

Genetic drift is a change in the gene pool of a population due to chance. In small populations, alleles may be lost or fixed by pure coincidence, regardless of their benefit or harm. Two specific types of genetic drift are frequently discussed in Campbell Biology:

- The Bottleneck Effect: Occurs when a disaster (e.g., earthquake, flood, overhunting) drastically reduces population size. The surviving population is likely to have a different genetic makeup than the original population, often with reduced genetic diversity.
- The Founder Effect: Occurs when a few individuals colonize a new habitat. The smaller the group, the less likely the genetic makeup of the colonists will represent the gene pool of the larger population they left.

Gene Flow and Mutation

Gene flow is the gain or loss of alleles when fertile individuals move into or out of a population or when gametes (such as pollen) are transferred between populations. Gene flow tends to reduce genetic differences between populations. **Mutation**, on the other hand, is the ultimate source of genetic variation. It is a change in the nucleotide sequence of an organism's DNA, creating new alleles that can then be acted upon by selection or drift.

The Five Unifying Themes of Biology

Technical Analysis: The Hardy-Weinberg Equilibrium

To understand whether a population is evolving, biologists use a mathematical model known as the **Hardy-Weinberg Principle**. This principle states that the frequencies of alleles and genotypes in a population remain constant from generation to generation, provided that only Mendelian segregation and recombination of alleles are at work.

The Hardy-Weinberg Equation

The equation used to calculate genotypic frequencies is:

$$p^2 + 2pq + q^2 = 1$$

Where:

- p = frequency of the dominant allele (e.g., A)
- q = frequency of the recessive allele (e.g., a)
- p^2 = frequency of homozygous dominant individuals (AA)
- $2pq$ = frequency of heterozygous individuals (Aa)
- q^2 = frequency of homozygous recessive individuals (aa)

Additionally, $p + q = 1$. If the observed frequencies in a population deviate from these calculated values, it is evidence that the population is evolving.

Conditions for Hardy-Weinberg Equilibrium

A population must meet five stringent conditions to remain in equilibrium. In nature, these conditions are rarely met entirely, which explains why evolution is a near-constant process.

1. Very large population size: Minimizes the impact of genetic drift.
2. No gene flow: No migration of individuals or gametes.
3. No mutations: No new alleles are introduced into the gene pool.

4. Random mating: No sexual selection or assortative mating.
5. No natural selection: All individuals have equal reproductive success.

Evidence of Evolution: From Fossils to Molecular Biology

The Fossil Record

Fossils are imprints or remains of organisms that lived in the past. Comparative Anatomy and Embryology

Homologous structures are anatomical similarities in different species that represent variations on a structural theme present in a common ancestor. For example, the forelimbs of humans, cats, whales, and bats all share the same basic skeletal elements despite having different functions. **Vestigial structures** are remnants of features that served important functions in the organism's ancestors but are currently of little or no importance (e.g., the pelvic bones in modern whales).

Molecular Biology

Modern technology allows scientists to compare the DNA sequences and protein structures of different species. The more closely related two species are, the greater the similarity in their molecular makeup. This molecular data often confirms anatomical findings and provides a higher resolution of evolutionary relationships through **phylogenetics**.

Sexual Reproduction and Genetic Variation

While mutations are the ultimate source of new alleles, in sexually reproducing organisms, most of the genetic variation in a population results from the unique combination of alleles that each individual inherits. This variation is generated through three main processes during **meiosis** and fertilization:

- Independent Assortment of Chromosomes: Homologous pairs of chromosomes orient randomly at metaphase I of meiosis.
- Crossing Over: The exchange of genetic material between homologous chromosomes during prophase I of meiosis.
- Random Fertilization: The fact that any sperm can fuse with any ovum to produce a zygote.

This genetic shuffling ensures that every individual (except identical twins) has a unique genotype, providing the raw material upon which natural selection can act.

Comparison of Selection Types

To better understand how natural selection shapes populations, it is useful to compare different selection pressures and their outcomes.
